# WHO IS ELIGIBLE FOR DDD?

- Applicant is a citizen and a resident.
- Applicant has an intellectual disability or a developmental disability as defined in HAR §11-88.1-5.



# INTELLECTUAL DISABILITY

THIS IS A SUMMARY

REFER TO HAR §II-88.1-5 FOR COMPLETE LANGUAGE

**A diagnosis by a licensed psychologist or other licensed professional that meets DDD's requirements.**

**Concurrent substantial functional limitations in at least 3 of the following areas of major life activity.**

- **Self-care**
- **Receptive and expressive language**
- **Learning**
- **Mobility**
- **Self-direction**
- **Capacity for independent living**
- **Economic self-sufficiency**

**The limitations must be attributable to the intellectual disability.**

**Onset of the disability occurs before the age of 18.**

- Dementia
- Mental illness
- Emotional disorders
- Substance abuse
- Sensory impairment
- Learning disabilities
- Attention deficit hyperactivity disorder
- Spinal cord injuries
- Neuromuscular disorders

# THE INTAKE PROCESS

- Step 1: Applicant gathers information.
- Step 2: Applicant schedules a meeting with an intake worker.
- Step 3: Applicant meets with the intake worker.
- Step 4: Applicant submits any other additional information requested by the intake worker.





# THE INTAKE PROCESS: TIMEFRAMES

- The applicant has 90 working days after meeting with the intake worker to provide all requested information needed to make a determination of eligibility.
- DDD has 30 working days to determine eligibility for services once an application is complete.

# CASE MANAGEMENT SERVICES

Case managers assist individuals in the development of a person-centered service plan. Identifying strengths, needs, and available supports.

Case Managers assist in obtaining supports and services needed, which may include supports provided or funded by DDD.

## HOME AND COMMUNITY-BASED SERVICES FOR INDIVIDUALS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES-1915 (C) MEDICAID WAIVER PROGRAM

- An alternative to long-term institutionalized care.
- Assists individuals to live within their homes and communities.

# WAIVER SERVICES

Waiver services complement and supplement services available to individuals through the Medicaid State Plan and other federal, state, and local public programs, as well as the supports that families and communities provide.

- Individual Employment Supports
- Assistive Technology

- Non-Medical Transportation
- Personal Emergency Response System

# ELIGIBILITY CRITERIA FOR WAIVER

- Eligible for DDD services
- Meet level of care: Intermediate Care Facility for Individuals with Intellectual Disabilities (ICF-IID)
- Eligible for Medicaid/Long Term Care



# INDIVIDUAL SUPPORTS BUDGET

A person's individual supports budget is determined by:

- Their supports level (SIS® assessment).
- Where they live (licensed or certified residential home, with family, or living independently).
